The Executive are about to reconsider the Society's subscription categories and rates. The challenge we are seeking to address is due to several things. We have 8 different subscription categories, the lack of clarity between the different categories cause confusion for current and new members, and the difference in cost of these categories is not large:

Finally, the current subscription income does not cover the Society's fixed expenditure, which is not surprising as subscription rates have not changed for 10 years. The Society has had a longstanding principle of ensuring subscription income covers the Society's fixed expenses so that book, conference, sponsorship etc income can be used for discretionary activities such as travel grants, project grants and books.

The Executive believe it is timely to review the rates and categories, rather than just look at changing the rates. The plan is to prepare options for changes in early 2020 and include a proposal in Current in early 2020. Following feedback, the Executive intend to put a proposal to the Society's 2020 Annual General Meeting.
